

Muscatine County Board of Supervisors
Monday, July 27, 2020

The Muscatine County Board of Supervisors met in regular session at 9:00 A.M. with Holliday, Sauer, Sorensen, Mather and Saucedo present. Chairperson Sorensen presiding.

On a motion by Saucedo, second by Sauer, the agenda was approved as presented. Ayes: All.

On a motion by Mather, second by Sauer, claims dated July 27, 2020 were approved in the amount of \$836,358.66. Ayes: All.

Discussion was held with Eastern Iowa MHDS Region CEO Lori Elam and Mental Health Advocate Greg Burnett regarding a possible revised 28E Agreement. Elam stated having a mental health advocate appointed is part of code and Scott County has always served as employer of record. Elam stated the 28E was being revised to look at percentages of each county's caseload in the region on a quarterly basis. Elam stated Muscatine County is currently at 21%, but has had several cases dismissed so should be down next quarter. Burnett stated he currently has 63 cases in Muscatine County. In response to a question from Mather, Burnett confirmed that the percentages are based on number of cases, not how much time is spent on the cases. County Attorney Jim Barry asked how cases get dismissed. Burnett stated they come up for status review and the judge makes the decision on whether or not to dismiss them. Community Services Director Felicia Toppert stated it is part of the County's quarterly process to review cases to potentially get them dismissed. Mather stated he would like to receive a report of number of cases and their status on a regular basis. Toppert stated she receives that report on a quarterly basis from Burnett. On a motion by Mather, second by Saucedo, the Chairperson was authorized to execute a revised 28E agreement for mental health advocate services for the Eastern Iowa MHDS Region. Ayes: All.

On a motion by Saucedo, second by Holliday, minutes of the July 20, 2020 regular meeting were approved as presented. Ayes: All.

Discussion was held regarding a possible contract with Commercial Roofing for the Muscatine County Jail Partial Roof Replacement Project. County Attorney Jim Barry asked about project completion not mentioned in the contract. Saucedo stated Mike Nolan, Horizon Architecture, previously stated they intend to complete the project this year. On a motion by Sauer, second by Holliday, the Chairperson was authorized to execute a contract with Jim Giese of Commercial Roofing in the amount of \$243,045.00 for the Muscatine County Jail Partial Roof Replacement Project. On a motion by Sauer, second by Holliday, the Board approved Resolution #07-27-20-03 Transferring \$735,000 from the General Basic Fund to the Debt Repayment Fund. Roll call vote: Ayes: All. Budget Administrator Sherry Seright stated with this transfer there will be \$2,855,000 in the Debt Repayment Fund. Seright suggested \$1,855,000 of that be used to retire the Jail/DHS/HVAC loan which will leave \$1,000,000 in the Debt Repayment Fund, but lower the debt levy from 73 cents in FY20/21 to 62 cents in FY21/22.
